**2019/2020 Religious Education Parent Partnership Agreement**

Immaculate Conception Parish community strongly supports a Catholic education for all its Parish children and relies on the partnership of parents with the Parish and its' members to achieve the Christian formation of each and every child.

The Parish testifies to the magnitude of this support through subsidies offered to help run our program. *Without a Parish subsidy, our program tuition would have to increase significantly.*

Immaculate Conception Parish will continue to contribute to the cost of a child's religious education in our Religious Education Program if the following criteria are met by the students' parents:

- The family is registered as parishioners of the Parish.
- The parent(s) and Religious Education children attend Mass every Sunday (to honor the Sabbath) and all Holy Days of Obligation as part of the Catholic faith.
- The parent(s) actively participates through volunteer service to the Parish and participates in Parish RE programs and events.
- The parent(s) supports the Christian programs and mission of the Parish through weekly Sunday offerings by using the Parish envelopes.

*The Parish community realizes families may experience hardship in making substantial monetary charitable offerings on a regular basis. For those that are unable to make regular Sunday offerings, your intention to give and participation in Sunday Worship is made evident by the placement of the weekly Sunday offering envelope in the collection basket, even if the offering envelope is empty.*

- Parents pay tuition in full by October 1, 2019.
- At least one parent or guardian must attend ALL mandatory parent meetings. These meetings are usually for sacrament preparation and for parent informational purposes.

- Each family attends three parish functions during the school year.
- Parents will abide by the attendance policies listed in our handbook.



I agree to the requirements stated above, and am requesting that my child(ren) be accepted into the Immaculate Conception Religious Education Program. I understand that the Pastor will evaluate our status periodically during the year, including the summer months when Religious Education is not in session to ensure that active parishioner status still applies.
